#### **PROPOSITION**

Shall the City of Moore, Oklahoma, incur an indebtedness by issuing its bonds in the amount of Six Million Seven Hundred Thousand Dollars (\$6,700,000) to provide funds for the purpose of constructing, reconstructing, improving or repairing streets or bridges in said City, to be owned exclusively by said City, and levy and collect an annual tax, in addition to all other taxes, upon all the taxable property in said City sufficient to pay the interest on said bonds as it falls due, and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to bear interest at not to exceed the rate of 7 per centum per annum, payable semiannually and to become due serially within 20 years from their date

Section 2. The specific projects for which at least seventy percent (70%) of the proceeds of the aforesaid street or bridge bonds shall be expended, and the dollar amounts for each such project shall be as follows:

Project 1. Engineering and design expenditures and Resurfacing of Telephone Road from SW 34th Street south to the City Limits, which adjoins the City of Norman, Oklahoma.
